GENEALOGY OF THE WINN FAMILY

The Winns are very ancient and honerable family of Welph origin lineal descendents of the Kings of Britain and the Prince of Wales, and connected by Marriage with the best families of England and America. The sir name "Wynne" was assumed by John, the son of Meredith sp(?), Even of Gwydir in Carnarvan County, Wales born in 1500. The direct line of descendents from these Welch noblemen to our Wynnes and Winns of Virginia is not documental, but all Wynnes, Wynns, and Winns of Virginia have a common origin in the Welch family of that name.

Several very interesting families bearing the name of Wynne or Winn came early to Virginia. The very first of the Wynnes to arrive was Captian Peter Wynne who came to Jamestown, Virginia in the second supply ship with the Lord De La Ware in 1608. He died in 1609, leaving no descendents that are known. Sir Owen Wynne, of Gwydir came to Virginia in 1611, locating in Glouchester County. He returned to Wales, leaving two sons in Virginia. Captian Thomas Winn was in Charles City Missouri (?) before 1657, leaving a family of sons. The early history of these families are confused because many of the early records have been destroyed.

Of the interesting Winn families is one in particular, is a series of "Minor" Winns who lived in Prince William and Fauquire Counties, Virginia. They seem to have descended from the Winns of York, Hanover and Carolina Counties of Virginia.

John Winn of Middlesex, Hanover and Westmoreland Counties, Virginia, is supposed to have been the son of Sir Owen Wynne who in 1611 came to Virginia from Wales. He married Elizabeth Minor, believed to have been the daughter of John Minor of Westmoreland County Virginia. They had, with other children, two sons, Richard Winn, born 1670, the ancestor of the Winns of Middlesex County, Virginia, and Minor Winn, born about 1672, the ancestor of the Winns of Caroline, Prince William, and Fauquier Counties, Virginia.

SUPPLEMENTAL STATEMENT

No positively new discovery, but it appears that Captian John Winn, (Wynne) who married Elizabeth Minor, was the son of Sir Owen Wynne, the fourth son of Sir John Wynne of Gwydir in Wales. Sir Owen Wynne came first to Virginia in 1611, returned to Wales. and came again in 1620 and returned to Wales in 1649 to succeed his brother as the third Baronett Wynne. He left in Virginia two or three sons: Captian John, Owen and probably Hugh. When Sir Owen died in 1660 he was succeeded by his younger son Richard Wynne. A long period of strife and litigation followed and that branch of the family in Virginia changed the spelling of the name to Wing; this began the sons of Captian John Wynne. Richard Winn and Minor Winn were sons of the Captian John Winn (Wynne). Richard Winn, son of the John Winn and Elizabeth Minor, born about 1670, ancestor of the Winns of Middlesex County Virginia, married first Sarah , and second, Ann Cooke. (Information taken from Christ Church Parish Register --- see book " Winn and Jarvis). Richard and his wife Sarah had ten children.

- 1. Mary Winn, probably died young as another child was given the name.
- 2. Sara Winn, baptised 1698.
- 3. Richard Winn, baptised September 28, 1701, married Mrs Phoebe Pledger, Hanover records show January 1733, Richard Winn and his wife Phoebe sold land to John Winn 514 acres on the Chickohominy Swamp. This land was bought by the said Phoebe when she was the widow Pledger. After selling this land they moved to Amelia County. Records show that Richard Winn of Hanover bought land in 1755
- 4. Elizabeth Winn, baptised April 18, 1703.
- 5. John Winn, baptised January 20, 1705. He died about 1789. He owned a great deal of land in Hanover County, Virginia, along the Chickominy Swamp, also owned land in adjoining counties. His home was called Jessamine Lawn and he gave the land on which the first Baptist Church in Hanover County was built, which is still known as Winns Baptist Church. It was here that John Clay, father of the famous statesman Henry Clay, was the first Pastor; also, Ruben Benjamin Bowles and John Walter were early pastors of the church. John Winn married Mary ---- and had five children:
 - 1. Hezekiah Winn, born 1749, married Christiania Bowles, daughter of Thomas Bowles. She was born August 8,1753. They lived on the Chickohominy Swamp in Hanover County, Virginia. He died 1792. They had three sons: John, Minor and Thomas.
 - 2. John Winn, born 23 December 1751, died in Hanover county, Virginia. 16 November 1842. He married Mary Bowles, sister of Christiania Bowles his brothers wife. Mary was born 8 August 1753. John served in the Revolutionary War.

He was born in Hanover county Virginia. He married He married Elizabeth Dabney Anderson in June 1780. Was a Major in the Revolutionary War. The home of Major Thomas Winn was in Fluvanna county and called "Lowfields". His children were: George, Ann Ancell, Elizabeth Pledger Woodson, Frances Cleveland, Captain John Winn, and Mary Winn. Major Thomas Winn died at the home of his son Captain John Winn, in Fluvanna county, Virginia. He and his wife are buried at Winnsville, Fluvanna County Virginia.

4. Peter Winn, lived in Hanover county and married Mrs. Sally King, nee George, born Henrico Co. Virginia in 1785.

5. Ann Winn, married Nathaniel Holman of Henrico Co. Virginia. He was First Lieutenant in the Revolutionary War. He was the son of Henry and Mourning Holman.

Jesse Durrett Winn: born in Carolina Co. Virginia 13 April 1752. He married first on 29 April 1770, Catherine Johnson, daughter of Colonel Stephen Johnson of Carolina Co. Va. who was an officer in the Revolutionary War. She was born 15 Oct. 1753, and died 17 June 1803. He married second, 8 Sept. 1807 A Nancy (Gordon) Colbert. Jesse served in the Revolutionary War. In 1788 he and his family left Carolina Co. Va. and moved to Kentucky, and settled at Bryon Station in Fayette Co. Kentucky.

Minor Winn11

Son of Minor Winn 1 and Miss Www. Byrd of Caroline Co. Virginia was probably born in Westmoreland Co. Virginia in 1704. He settled in Caroline Co. Va. before 1733, moved to Prince William Co. in 1737 and settled on Little River in Fauquier Co. Va. before 1765 buying the land from Richard Lee and building the first old stone house calling it " " Rock Hill". This place is spoken of as the old Winn place and is located about half way between Middlesburg and the Plains of Fauguier Co. Va. not far from Washington D. C. Minor Winn 11 probably married in Westmoreland Co. Margaret O'Connor from Ireland. He died in 1778. The will of Minor Winn 11 was made 31 July 1775 and was Supplemented Feb. 5 1778 and was probated in Fauquier Co. Va. 27 July 1778. (a copy of the will is attached hereto.) Minor Winn 11 owned considerable land and there are various old records of land transations, namely in Orange Co. order book 2 page 43, June 1737. Minor Winn of St. Margarets Parish Caroline Co. bought land in Orange Co. Virginia. Caroline County order book 1732-1740, suit of Minor Winn against Augustine Moregal was dismissed June 13,1735. Orange County order book 2 page 42-43: Minor Winn sold land in Orange Co. to Frances Thorton on June 23. 1737. Loudound County: Joseph Holtzclaw of Prince William sold to Minor Winn of Prince William County 300 acres on North branch of Goose Creek on 10 December 1763. On May 3. 1765. Minor Winn and himself the second and the sec his wife Margaret sold a lot in Leesburg, Loudoun, D. B. page 594, and on 27 April 1771, Minor Winn and Margaret O'Conner of Fauguier Co. sold 358 acres in Loudoun County. Minor Winn11 and his wife Margaret O'Conner had nine children. John, Minor, William, James, Richard, Margaret, Mary, Susanna and Elizabeth.

Of these children the five sons served in the Revolutionary War, all of them holding commissions, ranging from Colonel to Lieutenant. They all married and raised interesting families. Minor Winn 111 remained in Fauquier Co. Virginia and inherited "Rock Hill Plantation" and left an interesting family Colonel John, Colonel William Winn and Major General Richard Winn moved in 1765 to South Carolina where they laid out Winnsboro, the County seat of Fairfield County, South Carolina.

Colonel John Winn went with his brothers Richard and William to South Carolina in 1765. Where they founded the town of Winnsboro. These brothers also founded Mount Zion Society an instution of learning of which John Winn was first President. He was a member of the Provincial congress. John Winn married first Dorothea Wright of Alexandria, Virginia. They had seven children: Anna, Minor, James, John, Richard, Francis, Wright and Mary. John Winn and his second wife Penelope Kirkland had nine children: Joseph who married Cate West (and from this line came General Richard Winn of Missippi) Daniel, Harriet (who married ____ Vaughn of Missippi) Martha, Margaret (who married _____ Tucker of Tennesse) David, Jefferson, Obediah and John Winn.

The conditions of above obligation is such that where as there is a present a shortly intended to be solemized between the above bond

a marriage shortly intended to be solemized between the above bond Minor Winn and Bettie (Elizabeth) Withers now if there be no cause to obstruct the marriage than the above obligation to be voiced

or else to remain in force.

Colonel William Winn:

Third son of Minor Winn and Margaret O'Conner, born 1732. He went with his brothers Colonel John Winn and Major General Richard Winn to South Carolina in 1764 where they settled in Cauden District, called Fairfield, and laid out the town of Winnsboro, South Carolina. Colonel William Winn was living at "76" a town and military station in western South Carolina in 1790. He served with distinction in the Revolutionary War, returned to Virginia and moved to Lexington, Kentucky. Colonel William Winn lived in Craven, new Spartenburg, South Carolina, and lastly in Charleston, South Carolina. The date of his death is not known, but he is buried beside the first wife, Dorthea Wright, of his brother Colonel John Winn at Winnsboro, South Carolina. The deed book 6 p. 134, Fauquier County, Virginia. William Winn of Craven County, South Carolina appointed his son-inlaw Matthew Smith of Fauguier County Va. his attorney. Matthew Smith had married Martha Winn who was the remaining heiress of Ann Lingan whom William Winn referred to as his former wife. This power of attorney was witnessed by James Winn, Minor Winn Sr. Colonel William Winn married two times. First Ann Lingan of Baltimore, Maryland about 1753 and they had one daughter Martha, who married Matthew Smith of Fauquier County, Virginia. He married second about 1764, Rosa Hampton daughter of John Hampton and Margaret Wade of Fairfax County, Virginia an aunt of General Wade Hampton. Colonel William Winn and Rosa Hampton had four sons and six daughters. Namely: Rosa Winn, Margaret Winn, Mary Winn, Sarah Winn, Rebecca Winn, Susan Winn, John David Winn, James Winn, William Winn and Minor Winn lV. (see page 16)

Major Grneral Richard Winn. Fifth son of Minor Winn II and Margaret O'Connor, was born in 1750 and died 18 December 1818, in Maury County, Tennessee on Duck River. Possessed of 2500 acres of land and 40 negroes and valuable stock of all kinds. (Southern History Association, July 1898, vol. II, Richard Winn by J. L. Curry.) Richard Winn went with his brothers, John and William to South Carolina in 1765 and they laid out Winnsboro, S. C. He married Priscilla McKinley. He served in both the Revolutionary War and the War of 1812, being a Colonel in the War of 1812. "Major General Richard Winn (1750-1818), Colonel in American Revolution, Brigadier General and Major General S. C. Milita, Member of Congress 1793-1812 Judge County Court, etc. Died in Tennessee. In 1811 Brigadier General Richard Winn went to Maury County, Tennessee, and had 5,000 acres of land, named the place Winnsboro, Tennessee. There he died. His grave has been plowed over and there is no tombstone, although one was sent there years ago, but some fault, cannot be located. He was a fine mathematician and surveyor and his services were secured by weathly Englishmen to survey and locate lands for them, his compensation being every eight tract of land. Thus he secured large quantities of land before the Revolutionary War. At the beginning of the Revolutionary War he entered the services of South Carolina and was commissioned in June 1775 as First Lieutenant of Rangers in the attack of Sullivans Island. He so distinguished himself that he was in command of a special expedition for the defense of Fort McIntosh on the Saltillo River; returning to Fairfield, he took command of the militia and won in several hard-fought battles. Captain Richard Winn was severely wounded at Hanging Rock. The defeat of the British depended a great deal on his courage and conduct He was made Colonel before peace was declared. His home was looted and burned, slaves carried off and his family driven away. Colonel Winn held several civil offices and was elected Brigadier General and afterwards Major General by Legislature of South Carolina. On December 16, 1793, he took the required oath for the seat in the house of Representives where he remained until 1873. On 4 June 1812 he signed President Calhoun's bill declaring the second war for independence against Britain. Children of Richard Winn and Priscilla

WILL OF MINOR WINN II

Dated July 31, 1775. Recorded March 23, 1776 in Will Book I, Page 343, Fauquier County, Warrenton, Virginia.

In the name of God, Amen: I, Minor Winn, being of perfect mind and memory, thanks be given to the Almighty God for it, as touching my temporal affairs doth make this my last Will and Testament, first and principally I recommend my sole to God who gave it, having the death and person of our Blessed Lord and Savior Jesus Christ to recieve full and free pardon and forgiveness of all my sins, and for my body to the ground be decently buried at the discretion of my Executors here after named and for my Temporal estate which it has pleased God to bestow upon me I give and bequeath of in manner as follows, Viz:

ITEM: I give and bequeath to my beloved wife, Margaret Winn, all my estate royal and personal for and during her natural life.

ITEM: I give and bequeath to my son William Winn one Negro man named Godfree and in any persons whatever should season (seize on ?) the said for his debts then the negro shall be the whole and sole property of my granddaughter Martha Smith and her heirs forever.

ITEM: I give and bequeath to my son John Winn, one negro woman named Jean and one said negro boy named Ben and one negro boy named Moses now in his possession, also one negro boy named Lewis to him and his heirs forever.

ITEM: I give and bequeath to my son Minor Winn, one negro man named Rubin and one negro man named Solomen now in his possession; also my riding horse, bridle and saddle and all my wearing apparel to him and all his heirs forever; also my Great Bible in the same form and manner.

ITEM: I give and bequeath to my son Richard Winn, one negro man named Will now in his possession, also one negro named Tom during his natural life, and if my son Richard should without an heir lawfully begotten of his body then his part of my estate shall be devided equally among my children then living, and if he is got heirs lawfully begotten, I give it to him and his heirs forever.

ITEM: I give and bequeath to my daughter Margaret Johnson, one negro girl named Winney now in her possession, also one negro boy named Jack Monday to her and her heirs forever.

ITEM: I give and bequeath to my daughter Susanner Grant, one negro that she has in her possession named Dick, also one negro girl named Hanner and if my daughter Susanner Grant should die without heir lawfully begotten by her body then her part of my estate shall be equally devided among my children then living and if she has got heirs lawfully begotten I give it to her and her heirs forever.

ITEM: I give and bequeath to my grand-daughter, Martha Smith, one negro girl named Lucy now in her possession to be hers and her heirs forever.

ITEM: I give and bequeath to my daughter Elizabeth Smith, children fifty pounds to be devided equally among the whole after the decease of my wife, all the balance of my estate both royal and personal to be sold after the decease of my wife at twelve month credit with taking good bond and security and what remains after paying my just debts and funeral charges among my children then living by said wife Margaret Winn, Whom I appoint my Exectrix with my son Minor Winn, my whole Executor of this last Will and Testament and during the life of my Exectrix with my Executor, is to act and do as she thinks proper and it shall stand good to this my last Will and Testament.

Witness Whereof I have here unto set my hand and seal this thirty- first day of July one thousand seven hundred and seventy-five.

I, Minor Winn, of the County of Faquier, being sick and weak in body and of sound sense and memory, do so desire that this instrument of writing be annexed to my last Will and Testament

and taken and accepted as a part thereof.

Whereas I, some time ago purchased a tract of land of Mr. Martin Pickett lying on the south side of Little River part of a tract formerly belonging to Holtzclaw, and have the said Pickett's bond for making me a title to the same as soon as he can obtain a degree of the court to put him possession thereof. I do here give and bequeath my right of the said land to my son Minor Winn and desire that Col. Pickett may make deeds for the same to my said son Minor Winn whenever he shall be enabled to

do so by obtaining the degree aformentioned. And whereas I have in partnership with my son Minor Winn erected a Still house in the said Minors land and furnished the same with stills and necessary utensils for carrying on the distilling business, and have likewise in partnership with him raised a stock of hogs at the said still house and purchased a set of blacksmith's tools, the profits of which several articles were by bargain to be equally edvided between my said son and myself during my life and after decease, between my wife Margaret Winn and my said son Minor Winn during her life. My desire is that the stills, stock, tools, etc. be kept together during the said life of my wife Margaret and the profits arising there from be equally devided between my said wife and son Minor Winn and after her decease the said stills, utensils, stock and tools shall be appraised by persons on oath and my said son Minor shall be at liberty to keep the same on paying one half of what they shall be appraised, to my Executors for the benefit of my

estate to be applied in the same manner as some other part thereof which by my will I have directed to be sold. In witness of my desire that this shall be taken as part of my last Will and Testament I have here unto set my hand and seal this Fifth day of Feburary in the year of our Lord one thousand seven hundred and seventy-eight.

WILL OF MINOR WINN III (1813)

In the name of God, Amen: I, Minor Winn, of the County of Fauquier and the State of Virginia, being sick and weak in body but of sound and perfect memory, do make and ordain this my last will and testament in manner and form following, to wit:

In the first place I desire that all my just debts shall be paid. I give and bequeath to my beloved wife Eleanor Winn the followingslaves, Reuben, Syd, Daniel, and Mary and Mary's increase, and my désire is that the said slaves shall never move out of the Counties of Fauquier, Prince William, or Loudoun, nor be hired out, but retained in my said wife's own possession during her natural life and after her death be sold to the highest bidder on credit of twelve months, and the money arising from such sale be equally devided among my children and in case of my wife's removing the aforementioned slaves out of the counties above mentioned or hiring them out, such removal or hiring them out I hereby declare to be a forfeiture of her claim to them (unless the same shall be done with the consent and approbation of my executors here after named) and order them to be sold on a credit of twelve months and the money arising therefrom to be equally divided among my surviving children. I also give to my said wife, one bureau, one small dining table, one small poplar table, all my china, earthen and glass ware which is kept in the Beaufet or Dairy, also her choice of all my creatures of the horse kind and a saddle and bridle, two cows and calves, four ewes, and a sow and pigs, all my fowls of every description, twenty barrels of corn, twenty bushels of wheat, five hundred pounds of pork, or two hundred and fifty pounds of bacon in lieu of the pork if it be her choice, and five thousand pounds of hay for the immediate use of her stock and of the cattle of my wife , my will is that the horse, saddle and bridle, the stocks of the cattle, sheep and hogs and the furniture which I have left to her shall be given to my daughter, Nancy Harrison and to her heirs. I also give to my dear wife a negro boy named Alfred (who came to me by her) to be hers and her heirs. And to provide a place for my wife's residence in the future, I leave it to her choice either to recieve twenty pounds a year for the term of five years if she shall live so long, which my executors are hereby ordered to pay her annually during the aforesaid term, or to hold during her life my hot of Graham's land where on Thomas Garner lived, but to recieve the twenty pounds and the aforesaid lot of land also.

ITEM: I give and bequeath to my daughter Nancy Singleton a Negro Mary and her increase and an equal part of the money arising from the sale of the personal property by this my last will and testament ordered to be sold in trust in the hands of Isham O'Bannon and the profits of which I bequeathed to her to be by him laid out at his discretion for my said daughter's support, and if it shall hereafter appear necessary to him from the conduct of Mr. Joshua Singleton the husband of my said daughter, Nancy Singleton, I hereby empower him, the said Isham O'Bannon, to take the before mentioned negro Mary and her increase out of the hand's of the said Singleton and to layout what ever profits may arise from them for the sole use of my aforesaid daughter and after her death my will is that the slaves aforesaid shall be sold on twelve months credit and the money accuring from such sale equally divided among her children as they shall marry or become of age.

ITEM: I give and bequeath to my daughter Sally Gibson the wife of William Gibson, two negro women by the name Esther and Ailey, with their present and future increase. I also desire that my said daughter may have my negro boy David at the appraisement price, if she chooses to give it.

ITEM: I give and bequeath to my daughter Margaret the wife of Thomas (Neal), negros Jenny and Winny and their increase to her and her heirs.

ITEM: I give and bequeath to my daughter Betsy the wife of Moses Gibson, a negro woman Lavina and her increase, also the sum of one hundred pounds arising from that part of my estate which I direct by my will to be sold.

ITEM: I give and bequeath to my daughter Susanna the wife of Edward Simpson, negroes Nan and Jude and their increase.

ITEM: I give and bequeath to the daughters of my deceased daughter Mary, late wife of Isham O'Bannon, and her son Minor O'Bannon, negroes Sarah and Esther and their increase to be given to them when they marry or become of age.

ITEM: I give and bequeath to my son John Winn, negroes George and allegany now in his possession, also my wearing apparel and my best riding horse and saddle and bridle after my wife has had the first choice of my horses and mares.

ITEM: I give and bequeath to my daughter Hannah, the wife of Richard Neale, negroes Liz and her children Armistead, Doll and Sarah and their future increase.

ITEM: I give and bequeath to Minor Winn, negroes Sam and Bett and Bett's increase.

ITEM: I give and bequeath to my son Thomas Winn, negroes Lue and Charlotte and Charlotte's future increase, one feather bed and furniture two cows and calves, four ewes and a sow and pigs.

My will is that as soon after my death as public notice in the Gazettes can conveniently be given, my lands shall be sold to the highest bidder on a credit of three years, bonds with approved security to be taken bearing interest from the date and also a deed of trust on the land for more affectually securing payment of the purchase money; the interest to be paid annually and in case of failure the term of credit to be forfeited.

ITEM: My will is that the whole of my personal property not herein bequeathed shall be sold by my executors hereafter named on a credit of twelve months, the purchasers giving bond with good security to bear interest from the date if not punctually paid when due and the proceeds of the said sale together with the money arising from the sale of my land(after paying to my daughter. Bettsy Gibson the hundred pounds herein before given to her) to be equally divided among all my children then living and the daughters of my late daughter Mary O'Bannon and her son Minor O'Bannon (the aforesaid children of my said daughter to have divided equally anong them the part which would have fallen to their mother if she had been living) excepting my daughter Nancy Singleton whose proportion thereof I leave in trust to Captain Isham O'Bannon for her use to be advanced by him as her necessities shall in his opinion call for the same, and after her death the

remainder (if any) be equally divided among her children then living.

And lastly I do here by constitute and appoint Captain Isham O'Bannon, Er. William Gibson and my son John Winn executors of this my last Will and Testament, hereby revoking all others by me heretofor made.

Winn, or unto the hands or possession of any other person or persons for him and the same to made, do exhibit in the county Court of Fauquier at such times as he shall be thereunto required by the said Court and the same goods, chattels and credits and all the other goods, chattels and credits of the said deceased, which at any time after, shall come to the hands, possession or knowledge of said John W. Winn, or into the hands possession of any other person or persons for him to well and truly administer according to law. And farther do make and full true account of his acting and doing thereon, when thereto required by the said Court, also shall well and truly pay and deliver all the legacies contained and specified in the said testament, as far as the goods, chattels and credits, will there unto extend and the law shall charge then this

obligation to be void, and of none effect, or else to remain in full force and virture.
